## **On-Site Voting closes at 1:00 p.m.**

The purpose of the meeting is to vote on a proposed designated special assessment and to elect directors to fill terms that expire March 26, 2016. Election results will be posted by April 6, 2016 online at [www.apacheshorespoa.com](http://www.apacheshorespoa.com) and on the bulletin board outside the ASPOA office.

All owners are eligible to vote. Spouses and other joint owners shall constitute one member; only one vote per property is allowed; each owner/member will have only one vote, regardless of the number of lots owned. Votes may be cast one of three ways: 1) submitted online to ASPOA's electronic voting contractor, 2) mailed to the independent Election Judge, or 3) delivered in person to the independent Election Judge at the 2016 Annual Meeting of the Membership.

- 1) Submit *online* by 1:00pm, March 24, 2016 at [www.apacheshorespoa.com](http://www.apacheshorespoa.com). Click on the  icon. Enter your special code (special code is specific to your address only and is found on the address page of this mailing), complete registration, follow prompts and cast votes. You will receive a confirmation of your vote if you provided your email address at registration.
