You are not required to submit a bio to have your name placed on the ballot, but if you would like to have your bio included in the meeting notice, please include your bio on the Application. The bio should be no more than 100 words and should include information about you (such as how long you have lived in the community, prior leadership roles in the Association or other organizations); why you are interested in serving on the Board; and any education, training or experience that you believe makes you a good candidate.
